The Forest Service moved the shed that we share with FDRD from the Dillon work area to an area near the Officer's Gulch exit. Some of our and FDRD equipment, tools are there. For convenience for our Summit County Trailhead Host, we have distributed the 6 kits at different VWR houses. Please contact one of the following people to arrange to pick up a kit. Materials for Resupply are currently available at Joan Betz's cabin, or at the VWR resupply container at the Forest Service Office in Silverthorne. Pick up the DRD rec guides there also; they are 2023 version, but no reprinting until these are gone.

Meanwhile, VWRs interested in doing Trailhead Hosting shifts should contact one of the following people and arrange to borrow and then return the Kit and Table to that person.
